- PropertyPals does not take custody of user funds
- PropertyPals is not responsible for contractor or tenant conduct relating to payment disputes

All contractors are independent providers. PropertyPals does not supervise or guarantee the quality or legality of contractor services. You are responsible for evaluating contractors and resolving disputes directly with them.
